1. Type of Personal data collected

As part of this activity, we need to manage personal data which were collected in the registration form such as first name, last name, email address and Company (potentially).

2. Person in charge of personal data collection

3. Purpose of personal data collection

4. Which personal data do we collect?

5. Personal data recipient

Diversidées can take any required measures to ensure a safe management of its website and IT system.
